# B. Foundation for Saline Area Schools Update

Executive Director, Stacey Rumpsa

Executive Director Rumpsa provided the Board with the annual FSAS update. Points of pride for this year include raising \$33, 500 in donations, \$84,500 in sponsorships, and \$92,500 in fundraising events. Grants totaling \$90,000 were awarded which included \$32K in teaching and student grants and \$68K in building and district grants. Students from K thru Young Adult will reap the benefits from these grants. A video was shown to highlight some of the grants which included 3D Printers, Wall of Wonder and Inclusive Design (t shirt design) for Life Skill students. Fundraising events are being planned for fall and spring. More information to come.

### C. Bond 2022 Project Update

Executive Directors, Rex Clary & Kara Davis

Updates on bond projects. The process is both time and labor intensive. We're just starting but about \$45 million dollars of design work is in process. The collaboration process is very exciting, from the district design team brainstorming with community members and students and other focus groups and then design decisions being made. Site/Floor plan were shown for the HS STEAM addition, Weight Room addition to the HS, Liberty Recreation Complex and Playgrounds. The HS Operations Center is the first project to begin work and some of the material costs will be approved at the July board meeting.

# B. Policy Committee Discussion PO 2240

Jenny Miller, Committee Chair

Currently called the Controversial Issues Policy. This policy has been discussed for several years with no resolution. More earnest discussions began in February 2023 with opportunities for

public comment and full board discussions. There are some legally required opt-outs which are in separate policies and documents. This policy is not one of those. Legally students have rights to opt out of: 1. Sex Education 2. surveys, analysis or evaluations that inquire about sensitive information, 3. instruction of the characteristics of the symptoms of a disease in conflict with religious beliefs, 4. instruction on child sexual abuse and 5. the right to be free from compulsory physical examinations or medical treatment. These are different from the opt out policy in discussion and would not be affected by this policy. Regarding burden on teachers, the policy proposed would create consistency throughout the district, to help align all buildings with the same process. This policy affects instructional materials only. Chair Jenny Miller read the proposed draft. President McVey facilitated discussion among the full board.

#### 10. ADMINISTRATION / BOARD UPDATES

**Superintendent Laatsch:** The Sex Education Advisory Board has been getting inquiries as to the transparency regarding members of the SEAB Board. Currently new members are being selected for open positions. In years past, member names were made public and had been the target of unjust harassment which led to the current practice to keep the names private. So after some collaboration with the district team, the names for the upcoming board will be provided to the public in the similar way that the DEI AC names were made public. This is in an effort to remain transparent and gain trust with the community. June is Pride month and I was honored to help raise the Pride flag at City Hall with other city officials and community members.

**Trustee Austin:** Thank you to everyone involved in graduation.

**Treasurer Gerbe:** Thank you to everyone involved in graduation. Also very appreciative of the work done recently at the BOE/City of Saline Retreat held Jun 1, 2023 at the WISD. Lots of great work and efforts were put forth by both groups and look forward to continued collaboration.

**Secretary Miller:** Thank you to everyone involved in graduation. Especially grateful for the music components and for the appearance of Officer Gassaway, who has an amazing connection with students. Next policy meeting will be June 20, 2023 at 4:30 pm.

**President McVey:** Thank you to everyone involved in graduation. It's an honor and privilege to be part of this event.

**Trustee Gold:** In regards to policy 2240, feels that there is community consensus that does support the idea of some parental discussion and opt out. The policy isn't used frequently, but educators need guidance and support and the title of the policy "controversial issues" causes harm. We've also gotten feedback that if we would leave politics and diversity out of the classroom and just get back to basics that we would solve this issue. Shared the story of Alan Turing. By honoring the diversity of our students, staff and community, we are not abandoning academic success, we are contributing to it.
