#### 8. <u>SCHEDULED REPORTS</u>

#### A. Enrollment Update

Superintendent Laatsch

Dr. Laatsch presented on district enrollment. Since the 18/19 school year, enrollment has gone down, seeing sliding numbers even before the pandemic. This past school year enrollment was reported at 4,740 which was a slight (41) decrease from the previous year, noting it was the smallest drop since before the pandemic. County and statewide projections are showing that enrollment is declining throughout the area and state and projections are showing that will continue in Saline as well. The district has budgeted for declining enrollment. The district will begin work on a plan to market the school district partnering with the city as well. It's important to be seen as a destination district and to showcase all that the schools have to offer. In addition to new housing developments, there are job opportunities as well bringing people to the area. Toyota will be creating 200 new jobs at their facility located in York Township. Through School of Choice, we do bring in students from other Washtenaw county areas. Public education isn't going to meet the needs of all students and the district isn't able to support the needs being sought out by homeschooled and religious education students.

# B. Report of all Verified Bullying

Superintendent Laatsch

Dr. Laatsch presented the bullying report to the Board. This report was based on data that was documented as "bullying" from student discipline forms. He candidly spoke that the district must do a better job. Reports that were pulled were defined by bldg administrators as "bullying". The definition can be interpreted in different ways. This will be discussed with administrators at the start of the new school year. The handbooks have been updated to provide consistency throughout. He reviewed the incidents. Dr. Laatsch outlined the ways in which the district is trying to prevent bullying, citing culturally responsive instruction, social work and counseling support, advisory times at both the HS and MS, WEB and Link Crew as examples.

#### Board of Education Meeting Minutes July 11, 2023

**Superintendent Laatsch:** Welcome to our new Director of Communications & Community Relations, Jackie Martin. Dr. Ryan Rowe who was the Executive Director of the SWWC, was recently promoted to be the county director of CTE. This is needed because of expanded programming including the east side of the county. Kara Stemmer will replace Dr. Rowe as the new Director of the SWWC.

**Treasurer Gerbe:** made a statement regarding public comments, social media and public decorum. 3 functions of a Board: 1. assisting and evaluating our Superintendent, 2. create policies to support student learning and 3. help to maintain a fiscally responsible district. Asking the public to please take these things into consideration when making posts or comments.

**Vice President Steben:** Thank you to the retirees for your many years of service and thank you and congratulations to our graduates. Shout out to HR, Operations and Technology for all the work that occurs during the summer months.

**Trustee Estep:** Thank you to everyone who has personally reached out to me, contacted the Board and Superintendent to stand up against hate who is being directed at people who support our LGBTQ+ students and progress in DEI in our district.
